PSAC / NEU Government of Nunavut Members

- O Your Bargaining Team has reached a tentative agreement with the GN
- The details of the agreement have been posted on the NEU website.
- O The PSAC and a bargaining team member will provide additional details of the agreement in virtual meetings from November 18 to December 3.
- To make sure all GN Members get the chance to vote, there will be eight (8) opportunities to attend an information session and vote. See below for times.
- MEMBERS must be a Member in Good Standing by <u>signing a PSAC membership card</u> AND attending an information session in order to vote.
- Location: Virtual Zoom session, you can join on a computer or by phone.

To vote:

- 1. Sign a union card or check to make sure you have your PSAC card and ID number.
- 2. Attend an in-person session if you can. Register for an information session on Zoom through **one** of the following links for dates: Nov 18-20 | Nov 25-27 | Dec 2-3
- 3. Cast your ballot in person or vote by email online after attending one of the Zoom meetings below.

In order to ensure that members are fully informed prior to casting their ballot, the PSAC Constitution requires all members to attend an information session before they vote for a new collective agreement. These presentations allow members to cast their ballot once the presentation is over. Members will also have the opportunity to stay online after the presentation should they want to ask questions regarding the content of the tentative agreement.

This is an important opportunity to participate in a vote to ensure that the results truly reflect the wishes of members in this bargaining unit.
