Greetings NEU Convention Delegates!

This message is a call for the election of one (1) President and four (4) Vice-Presidents to the positions listed above: First, Second, Third and Fourth Vice-President.

Who can run for the NEU President and Vice-Presidents?

In accordance with Bylaw 12, Sections 2 and 3, any NEU member in good standing who is an accredited delegate to the 2026 Triennial Convention may be nominated. They must be nominated and seconded by accredited delegates to that convention.

What is an NEU President and Vice-President and what do they do?

The NEU President and Vice-Presidents sit on the executive of the Nunavut Employees Union to represent NEU members in the governing and decision-making of the Union, attend all meetings of the NEU executive and support all the locals and communities across Nunavut.

The President is a full-time paid role based at the NEU office in Iqaluit.

An elected Second, Third and Fourth Vice-President can expect to travel to Iqaluit (usually) for executive meetings and to other communities in Nunavut for Union business.

How do the elections happen?

According to NEU By-Law 12, Section 3, the President and Vice-Presidents are nominated, seconded and elected by NEU members in good standing who are accredited delegates to the 2026 NEU Triennial Convention by a secret ballot.

Nominations must be received in the NEU office by 6 AM ET on November 16, 2026. They can also be received on the floor during the election.

How do I get nominated?

If you are interested in being nominated, please see the forms on the next pages. Your nominator and seconder must also be delegates to the 2023 NEU convention and be members in good standing. Emails containing the same information as the forms will be accepted.
